Section I. Statement of Authority.

This Local Law is authorized by the New York State Constitution, the provisions of the New York Municipal Home Rule Law, the provisions of the Statute of Local Governments, the relevant provisions of the Town Law of the State of New York, the laws of the Town of Yorktown and the general police power vested with the Town of Yorktown to promote the health, safety and welfare of all residents and property owners in the Town.

Section II. Section 275-6(A) of the Code of the Town of Yorktown is hereby amended by adding the following full stop locations:

Hanover Street	at the Northwest and Southeast corners at its intersection with Underhill Avenue
Colonial Street	at the Northeast corner at its intersection with Granite Springs Road
Sycamore Road	at its Northeast corner at the intersection with Sheila Court and the southwest corner at its intersection with Forest Court
Crescent Drive	at the Southwest corner at its intersection with Larkspur Street
Larkspur Street	at the Northeast and Southwest corners at its intersection with Crescent Drive

Section III. Severability

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudicated finally by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this

local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby declared to be the legislative intent that the remainder of this local law would have been adopted had any such provisions been excluded.

Section I. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed, to the extent of such inconsistency.

Section II. Effective Date.

This local law shall become effective upon filing in the office of the Secretary of State in accordance with the provisions of the Municipal Home Rule Law.
