TCAC reviewed the tree permit request for 1425 Sunflower Dr. 3 of the eleven trees listed for removal are 6" in diameter and therefore do not count toward the total trees to be removed. With only 8 eligible trees impacted by the project, and only 2 in the buffer area, a tree permit is not required. However TCAC does encourage the implementation of the tree protection measures described in the plans to minimize the projects impacts to the nearby trees.
