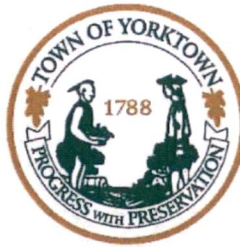

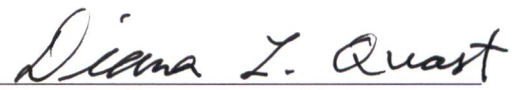
Whereas, Lanza Corp. did not include the masonry work in their bid and withdrew their bid; Complete Signs was the second lowest bidder and did not provide the hardware specified and the software included did not meet the functionality of the specified equipment; now

Therefore Be It Resolved, upon recommendation of the Town Engineer, the bid for the John C. Hart Memorial Library and ACCCC Digital Sign Installation, is awarded to Gloede Neon Signs. at a total bid price of \$122,092.00; and

Be It Further Resolved, the Town Comptroller is hereby authorized to process the following budget transfer:

From: A.1002	General Fund – Fund Balance	\$18,536.00
To: HV.1630.0200	Capital Projects – Town Buildings	\$18,536.00

To transfer funds to the Capital Project - Town Buildings for the purchase of Outdoor Digital Signs for the Albert A. Capellini Community Center and the John C. Hart Memorial Library. The original project funding of \$103,556.00 has been increased by \$18,536.00 following the award of the bid, for a total project funding authorization of \$122,092.00 payable to Gloede Neon Signs, with \$100,000.00 reimbursable through CREST Grant #28271.
