STORMWATER ANNUAL REPORT

Environmental Consultant Bruce Barber gave his annual presentation on the Town's MS4 Compliance Report. Mr. Barber explained that the Town of Yorktown has met all of the six criteria required by New York State including the distribution of nearly six hundred pieces of literature from two kiosks, a mailing of stormwater related material to more than 14,000 people and training sessions for 19 construction site operators.

ILLINGTON ROAD

Mrs. Diana Saunders explained that she has lived on Illington Road for fifty years. There is a six acre parcel, contiguous to her property that she would like to purchase. Her family has worked to keep the property from becoming a dump and has restored some of the tombstones on the site which had been a cemetery.

Councilman Bianco explained that the Town of Yorktown dedicated this property as parkland several years ago. He is not in favor of selling parkland.

Mr. John Schroeder, President of the Yorktown Land Trust thanked the Saunders for their stewardship of the property, but believes it should not be sold.

Supervisor suggested sending a referral on this request to the Open Space Committee, the Conservation Board and the Recreation Commission.

ALGONQUIN/MUNICIPAL ALIENATION CHECKLIST

RESOLUTION #241

Upon motion made by Councilman Bianco, seconded by Councilman Patel,

WHEREAS, Algonquin Gas Transmission Company, now known as Algonquin Gas Transmission, LLC, ("AGT"), is seeking approval from the Federal Energy Regulatory

Commission ("FERC") under the Federal Natural Gas Act to replace an existing 26-inch diameter natural gas pipeline with a new 42-inch diameter natural gas pipeline along portions of its existing pipeline right-of-way from Rockland County, New York to southern New England (the "Algonquin Incremental Market Project" or "Project"); and

WHEREAS, the existing 26-inch diameter natural gas pipeline is located in a Townowned park known as Sylvan Glen Park Preserve and Granite Knolls (referred to hereinafter as "Granite Knolls Park West") (Sylvan Glen and Granite Knolls Park West referred to collectively as the "Park"); and

WHEREAS, the portions of the Park that would be impacted by the Project include areas having tax map identification numbers 25.20-1-8 ("Parcel A"), 25.16-1-25 ("Parcel B"), 26.13-1-1 ("Parcel C"); 26.13-1-1.1 ("Parcel D") in Sylvan Glen Park Preserve, and 26.09-1-22 (Parcel "E") in Granite Knolls Park West; and

WHEREAS, the Town Board of the Town of Yorktown approved Resolution No. 204/2014 on May 6, 2014, as a preliminary step with respect to the Project, requesting the New York State Legislature to enact legislation granting permission to the Town to alienate portions of the Park for the Project; and

WHEREAS, the State Legislature introduced such legislation in the Assembly as A. 9673A and the Senate as S.7484A; and

WHEREAS, the Project will require AGT to construct certain new permanent abovegrade facilities on up to one acre of the Park on and adjacent to the existing easement area in Parcel E; temporarily utilize 15.4 acres of Parcel E for a contractor ware yard; and require approximately a total of eight acres of temporary work space adjacent to the existing easement upon Parcels A, B, C, D, and E to facilitate construction work along the existing pipeline rightof-way (the temporary contractor ware yard and temporary work space collectively referred to hereinafter as the "Staging Areas"); and

WHEREAS, AGT seeks a permanent easement on Parcel E for the above-grade facility and a temporary, three-year license and construction permit on Parcels A, B, C, D, and E for the Staging Areas (hereinafter, "License"); and

WHEREAS, the above-described alienations would be subject to the requirement that AGT implement specific mitigation measures including (1) constructing a new access road to the Park from Stoney Street and a new gravel parking lot with approximately 114 spaces; (2) creating the basic framework for a new ball field in the Park; (3) reconditioning and restoring the practice fields; and (4) providing funding for use of the Staging Areas; and

WHEREAS, the Town has concluded that the mitigation measures will result in longterm improvements to the Park and amenities for residents of the Town; and

WHEREAS, the Town Board has caused the *Municipal Information Form Lands Being Alienated or Discontinued* for the Sylvan Glen Park Preserve and Granite Knolls Park West (referred to hereinafter as the "Alienation Checklist") to be prepared pursuant to the <u>Handbook</u> <u>on the Alienation and Conversion of Municipal Parkland in New York</u> as issued by the New York State Office of Parks, Recreation and Historic Preservation ("OPRHP") that further describes the proposed alienations; and

WHEREAS, the proceeding before FERC requires FERC to conduct a thorough assessment of environmental impacts under the National Environmental Policy Act ("NEPA"); and

WHEREAS, the Town and AGT would not enter into the final easement agreement and License until FERC completes its environmental review under NEPA and the Town Board acts by separate resolution to approve the alienation; and

NOW, THEREFORE, be it Resolved that the Town Board of the Town of Yorktown hereby issues this Home Rule request in support and passage of Assembly Bill No.9673A and Senate Bill No.7484A; and be it

Further Resolved, that the Town Board approves the Alienation Checklist for distribution to the State Legislature and OPRHP; and be it

Further Resolved, that the Town Board requests the Town Clerk to forward a copy of this Home Rule Request to the State Legislature requesting passage of the above-cited bills.

AUTHORIZE SUPPORT TO TEATOWN LAKE RESERVATION TO CREATE AN ENVIRONMENTAL STEWARDSHIP TRAINING CENTER

WHEREAS, Teatown Lake Reservation, an environmental education center in Westchester County, is proposing to build on its 50 years of experience in environmental education and land stewardship by creating an Environmental Stewardship Training Center (ESTC) on its main campus. The ESTC will provide hands-on and classroom-based training to a variety of stakeholders including teens, professionals, and adult learners. This training will focus on building tangible skills such as trail design, construction, and maintenance, cartography, habitat management, and leadership.and

WHEREAS, Teatown Lake Reservation anticipatea that participants in the ESTC will become highly sought after in the job market through the intensive training they will receive. The target groups for receiving training at the ESTC include: interns from local high schools; adult learners/career changers; and managers of parks and preserves. and

WHEREAS, Teatown Lake Reservation already has strong ties to all of these groups that they are confident that they will have a large and sustainable pool of participants to draw from. and

WHEREAS, The Environmental Stewardship Training Center (ESTC) will function by providing training at Teatown and then working with local parks and preserves to place the skilled volunteers. This will extend the impact of this program to State and County Parks, as well as parks and preserves owned by NGOs and municipalities. Due to limited staffing at many

of these sites, there is a need for trained volunteers to steward these facilities. Moreover, as many parks in the lower Hudson Valley suffer from intense usage and environmental degradation (e.g., invasive plants), stewardship support will enhance the accessibility and sustainability of these areas from both a recreational and ecological perspective. As volunteers work at these preserves gaining experience, we anticipate that they will become highly marketable for paid positions either in the parks where they volunteer or at other organizations.

BE IT HEREBY RESOLVED, that the Town Board of the Town of Yorktown supports Teatown Lake Reservation in its efforts to create an Environmental Stewardship Training Center.
