TOWN BOARD MEETING

Supervisor Michael Grace called the meeting to order.

EXECUTIVE SESSION

Upon motion made by Supervisor Grace, seconded by Councilman Bernard, the Town Board moved into Executive Session to discuss various issues including litigation, certiorari settlements and the employment of a particular person.

Upon motion made by Councilman Bernard, seconded by Councilman Diana the Town Board moved out of Executive Session and proceeded with the meeting

PLEDGE OF ALLEGIANCE

Supervisor Grace led the salute to the flag.

MOMENT OF SILENCE

A moment of silence was observed in honor of our men and women serving in the Armed Forces.

WELCOME

Mr. Lyle Puente, President of the Mohegan Colony Beach Association welcomed the Town Board members to the beach.

Mr. Ken Belfer, President of the Mohegan Lake Improvement District and a member of the Mohegan Colony Beach Association explained that the Improvement District includes 1500 tax parcels surrounding Mohegan Lake. The District has an operating budget of \$95,000 per year.

Mr. Belfer also spoke about condition of the Lake stating that in early June, the Westchester County Health Department closed the beach due to high levels of blue algae. But, as soon as the copper sulfate treatments began, they could see an immediate change to the water.

<u>AUTHORIZE ADDITIONAL FUNDING FOR ALLIED BIOLOGICAL</u> RESOLUTION #337

WHEREAS on June 9th, 2015, the Town Board authorized the Town Supervisor to enter into an agreement with Allied Biological to perform the following services: for the benefit of the Mohegan Lake Improvement District: apply chemicals to Mohegan Lake during the summer of 2015 and perform water testing and DEC reporting for each application, and

WHEREAS the agreed upon contract price is \$2,025.60 per application for a maximum expenditure of \$10,128.00 to be paid from the Mohegan Improvement District's funds, and

WHEREAS, the Mohegan Improvement District has requested an additional copper sulfate treatment,

RESOLVED, the Town Board authorizes the Town Comptroller to pay for the additional treatment at the contract price of \$2,025.60.

DURING REPORTS FROM THE SUPERVISOR, Supervisor Grace explained that the Town had received notice that the New York State Department of Environmental Conservation has prepared a draft permit and has made a tentative determination to issue a renewal for the Yorktown Sewer Department's State Pollutant Discharge Elimination Systems (SPDES) permit with an upgrade in the amount of surface discharge. If approved, The Town of Yorktown would be able to issue sewer permits, something it has not been able to do in 28 years.

- 8. The Town will not be responsible for the condition of the dam on Salitan's property.

DURING COURTESY OF THE FLOOR, the following people spoke:

Mrs. Maria Donadio, a resident of Jefferson Valley asked the members of the Town Board if there were any plans underway to make improvements in her area. Supervisor Grace explained that he has made several trips to the area with the Highway Superintendent in an effort to make some improvements. Councilwoman Siegel also stated that she has telephoned the manufacturer of a lamppost that was knocked down during Hurricane Sandy several times. She has not been able to get them to tell her when the lamppost will be shipped. A meeting on this issue will be scheduled in the future.

Mrs. Janice Donadio, also a resident of Jefferson Valley showed the Town Board photographs of the area surrounding Osceola Lake which appear to be in disrepair and unkempt.

Mr. Tom Maietto thanked Ken Belfer and the Town Board saying the application of the copper sulfate was what Mohegan Lake desperately needed. He also thanked Town Comptroller Patricia Caporale for helping him with the paper work for his beach district.

Mr. Ken Belfer thanked the Town Board for coming to the beach. He asked the members of the Board if something could be done about the traffic hazard that exists at the intersection of Amazon Road and Oak Street where there is very limited visibility.

Mr. John Tegeder asked the Town Board for permission to work on Community Development Block Grant (CDBG) Applications for sidewalks in the Heights area of Yorktown.
