Item A: In chapter 270-4 Definitions

Protected tree; is defined having a dbh of eight inches or greater.

Therefore diseased or declining trees are not included.

Item B in Chapter 270 – 4 Definitions Mitigation Ratio states that the replacement rate expressed in base terms of diameter at breast height ie: DBH.

Therefore trees measured by height or caliper are not acceptable

These two items need to be corrected before the applicant can move on to Item F.

In chapter 270 - 10 C (4) Use of native species of trees if replanting is required.

For example, this applications planting schedule has the european little leaf linden

The TCAC needs a completed formula before granting a tree permit.
