Whether you support or oppose a proposal, attending a public hearing allows you to speak directly to your elected representatives. You can ask questions, express concerns, or simply listen to learn more about issues affecting our community.

To be held on the Town Board Meeting for July 1, 2025:

Public Hearing in relation to the proposed increase and improvement of the facilities of the Hallocks Mill Sewer District and Osceola Sewer District in said Town, consisting of pump station upgrades, including costs incidental thereto, at a maximum estimated cost of \$7,200,000 (allocated \$6,190,000 to Hallocks Mill and \$1,010,000 to Osceola).

To be held on the Town Board Meeting for July 1, 2025:

Public Hearing to consider a proposed Local Law to amend Chapter 300 of the Code of the Town of Yorktown entitled "ZONING," by amending the "Lake Osceola Planned Design District Overlay Zone" Section 300-256 (A) [1] by adding Tax Parcel 6.14, Block 1, Lot 2 to the Lake Osceola Planned Design District Overlay Zone Map. The applicant, Creative Living, has requested to add the 49.6-acre property located at 3000 Navajo Street to the Lake Osceola Planned Design District Overlay Zone for the purpose of redevelopment of the site as a mixed-use commercial recreation and multi-family residential development. The applicant seeks to construct the following: a 23,000 square foot athletic facility, a 5,500 square foot clubhouse, and 242 units of multi-family housing.

To be held on the Town Board Meeting for July 15, 2025:

Public Hearing for a proposed Local Law to consider amending Chapter 300 of the Code of the Town of Yorktown entitled "Zoning" regarding Breweries by adding a new Section 300-21C(17)(a)[5] regarding microbreweries and micro-distilleries
